## INSTRUCTIONS

- Use this form to request a new, duplicate, or replacement **Voter Photo Identification Card** (“Voter Photo ID Card”) from your county board of elections. The Voter Photo ID Card is a form of acceptable photo ID to vote in North Carolina. For more information about photo ID requirements in North Carolina, visit [ncsbe.gov/voter-id](https://ncsbe.gov/voter-id).
- Any registered voter may request a Voter Photo ID Card in the county where the voter is registered to vote. You do not need to request a Voter Photo ID Card if you already have an acceptable photo ID for voting (such as an active NC drivers license), but you may do so. Visit [ncsbe.gov/voter-id](https://ncsbe.gov/voter-id) to see the full list of acceptable photo IDs.
- If you are not registered to vote in the county where you now live, you must become registered to vote in that county before you submit this form.
- The Voter Photo ID Card expires 10 years from the date of issuance and is valid for voting purposes statewide in North Carolina. If you register to vote in a new county after being issued a Voter Photo ID Card, you do not need to request a new Voter Photo ID Card.
- You may get help completing this form, but you must sign or place your mark beside the “X” on the form.
- To request a **new** Voter Photo ID Card, submit this form in person to your county board of elections. The county board of elections will take your photograph and issue the card to you if you are a registered voter.
- To request a **duplicate** Voter Photo ID Card because you have lost your Voter Photo ID Card or it is damaged, submit this form to your county board of elections in person or by mail. You may also request a duplicate card from your county board of elections by telephone.
- To request a **replacement** Voter Photo ID Card because your name has changed and you have updated your voter registration with your new name, submit this form to your county board of elections in person or by mail. You may also request a replacement card from your county board of elections by telephone.
- *Completing this form will not change your voter registration record. If you wish to do so, please contact your county board of elections.*
