RZ-25-02

Patrick Creech made the presentation. Chris Clemmons has requested to rezone approximately 1 acre from Residential District One (R1) to Regional Commercial (RC) to allow for the use of used motor vehicle sales by right. The parcel is located in the area classified as Urban Services Area. The USA contains a mixture of commercial uses, including regional commercial.

Action Taken

Bud Caywood moved to recommend RZ-25-02 to the Taylorsville Town Council as presented; Dale Miller seconded, and the motion carried unanimously.

D-25-01

Patrick Creech made the presentation. William Clayton P.E. and Brandon Lee are seeking approval for a 40-unit town home development within the Player's Ridge Golf Course community in Bethlehem. The developer began clearing land prior to approval and obtaining all necessary permits. Staff finds D-25-01 consistent

with the 2045 Comprehensive Plan and Alexander County LDC. Staff recommends conditional approval pending resolution with NCDEQ violations and corrective action.

Matt Schrum moved to approve D-25-01 pending written confirmation that all violations, corrective actions, and conditions have been fully resolved and regulatory requirements have been satisfied; Zach Tyner seconded, and the motion carried unanimously.
